Welcome to Westlaw! Before you start your research session, you will need to review/accept a User Agreement and complete a brief registration.

If you agree with the terms of the Agreement, click on "I Agree" below, fill in the registration information and click on "GO" to submit the Agreement. - 1. Access to Westlaw®**

This Agreement is entered into to allow the public library that subscribes to Westlaw ("Subscriber") to permit user, as identified in the online registration ("User") to access and use Westlaw at Subscriber's location. Access to and use of Westlaw by third parties who have not completed the online registration and agreed to these terms and conditions is strictly prohibited.
- 2. Governing Terms**

All access to and use of Westlaw by User will be governed by the terms and conditions of (i) this Agreement, (ii) the Westlaw Subscriber Agreement between Subscriber and West governing Subscriber's use of Westlaw ("[Westlaw Subscriber Agreement](#)") with User being the Subscriber in that agreement), specifically including, but not limited to, the provisions regarding disclaimer of warranties, limitation of liability and responsibility for certain matters. User may not acquire any Westlaw software or password. In the event of a conflict between this Agreement and the Westlaw Subscriber Agreement, the provisions of this Agreement control.
- 3. License.**

Any remote access by User of Westlaw is strictly prohibited.
 - c. Rights in Data.** Except for the license granted in this Agreement, all rights, title and interest in Data, in all languages, formats and media throughout the world, including all copyrights, are and will continue to be the exclusive property of West and other contributors of Data.
